OPERATION AND MANAGEMENT (O&M) OF TECHNICAL TRAINING CENTRE (TTC) KHARAN UNDER THE PUBLIC-PRIVATE PARTNERSHIP (PPP) MODE

The Department of Labor and Manpower (DLMP) has a state-of-the-art, purpose-built Technical and Training Center (TTC) at Kharan. The Government of Balochistan (GoB) intends to operate and manage (O&M) the TTC Kharan on the Public-Private Partnership (PPP) model. The TTC-Kharan would specialize in indigenous and marketable innovative technologies to meet the immediate workforce requirements in Balochistan by utilizing existing infrastructure. With the mission of "producing knowledgeable, skillful, proactive & confident professionals in fields of innovative technologies and applied vocational skills, ready to contribute to socio-economic uplift of the region", the TTC-Kharan would be a ray of hope for the socio-economic uplift of the region. For details of the project background, scope of work and specifications, please refer to volume I (Technical Specifications) of the Request for Proposal ("RFP").

Single stage, two envelope procedure will be adopted. The successful bidder will be selected on the basis of Quality Cost Based Selection method. Bidders are required to submit only one (1) Bid, comprising of only one (1) original Technical Proposal and one (1) original Financial Proposal, and four (4) hard copies of each, with one (1) soft copy of each (on CDs/DVDS/USBs) and other supporting documents (as applicable), as identified in the RFP, no later than 12:00 hours PST on **09-03-2023**, at the submission address given below:

The technical Proposals will be opened on same date at 13:00 hours PST in the presence of the representative of the bidders who may wish to attend at the committee room of 'Planning and Development' (P&D) Department, Government of Balochistan, Civil secretariat, Zarghoon Road, Quetta.

After completion of the evaluation of the Technical Proposals, bidders who have submitted responsive Technical proposals in terms of the Applicable Evaluation Document shall be invited to attend the opening of the Financial Proposals. The date, time and location of the opening of the Financial Proposal shall be advised in writing to all the technically qualified Bidders by the BPPPA.

All bidders are required to furnish, as part of their Financial Proposals (in a separately sealed envelope) a bid security equivalent to two percent (2%) of the bid price. The Bid Security Shall be irrevocable, unconditional and on-demand bank guarantee in the form attached as Bidding form F2 (form of bid security) of part 2 (bidding forms) of Volume 1 of (bidding procedure) of the RFP, issued in accordance with the requirements set out in the instructions to bidders.

It is mandatory for the bids to be prepared using the standard formats for technical Proposals and Financial Proposals, as provided in the RFP. Bids that are not prepared on the prescribed formats may not be considered by **Evaluation Committee** (Technical and Financial Evaluation Committee TFEC). If any information required in the prescribed forms is found missing or written elsewhere, no credit will be given during evaluation and may also lead to rejection of the bid.

BPPPA may amend the RFP by issuing an addendum or corrigendum (as the case may be) as per the requirements specified in the RFP, at any time prior to the Bid submission date.

Subject to the provisions of the Applicable Evaluation Documents, BPPPA reserves the right to cancel the Bidding Process at any time prior to acceptance of bids.
